CITY OF PIKEVILLE BOARD OF COMMISSIONERS REGULAR MEETING MINUTES September 24, 2018 AT 6:00 P.M.

The Board of Commissioners for the City of Pikeville met in a regular called session on Monday, September 24, 2018. The meeting was held in the City Hall Meeting Room located at 243 Main Street, Pikeville, Kentucky 41501.

There being a quorum present, Mayor James A. Carter called the meeting to order at 6:00 p.m. Commission Members present at roll call were as follows:

MINUTES

The minutes for the previous regular meeting held on September 10, 2018 were in each Commission Member's agenda package. There being no additions or corrections, Commissioner Hartsock made the motion to approve the minutes as prepared. Commissioner May-Downey seconded the motion. Mayor Jimmy Carter called for discussion, there being none, the motion carried unanimously. 5-0.

BUSINESS FROM THE FLOOR

Presentation by the Kentucky League of Cities. Mr. Robin Cooper, Chief Member Services Office of KLC, presented the City with a first-time award, "City Government of the Year." The League of Cities represents over 300 Cities across the Commonwealth and this is the first year for this particular award. Mr. Cooper congratulated the City for all accomplishments on projects and for providing a bright future for the area through the development of Kentucky Enterprise Industrial Park and the recruitment of EnerBlu and Silverliner. Mr. Cooper adds that he has never been so proud to be part of a presentation and congratulates the City and everyone involved. Mayor Carter thanked Mr. Cooper and the League and all Employees that have come out to accept the award on behalf of the City.

Consider a request to adopt a proclamation in recognition of the presentation by the Kentucky League of Cities. Commissioner McNamee made the motion to approve. Commissioner May-Downey seconded the motion. Mayor Carter called for comments, and the Mayor, each Commissioner, and the City Manager congratulated the employees of the City, Expo, and UMG for their efforts and dedication. Mayor Carter called for additional comments, and there being none, the motion passed unanimously. 5-0.

PAYMENT OF CITY BILLS

The City Manager Philip Elswick requested the approval to pay city bills in the amount of \$1,167,445.58. Commissioner McNamee made the motion to approve. Commissioner Hartsock seconded the motion. Mayor Carter called for discussion, there being none, the motion passed unanimously. 5-0.

Brad Slone was present and submitted several requests to the commission for approval.

- 5. Consider a request to authorize and approve payment of Vaughn & Melton Consulting Engineers, Inc. Invoice No. 48, as submitted, for \$30,426.19 for inspections on the WWTP Upgrade Improvements Project and grant the Mayor the authority to sign and execute any and all necessary documents. Pay Request No. 7, as submitted, for \$690,986.95 for the KEIP Speculative Building Building Package and grant the Mayor the authority to sign and execute any and all necessary documents. Commissioner Shurtleff made the motion to approve. Commissioner Hartsock seconded the motion. Mayor Carter called for comments, there being none, the motion passed unanimously. 5-0.

- 10. Consider a request to authorize and approve payment of Rising Sun Developing, Inc. Pay Request No. 7, as submitted, for \$14,768.10 for the KEIP Speculative Building Site Package and grant the Mayor the authority to sign and execute any and all necessary documents. Commissioner McNamee made the motion to approve. Commissioner Shurtleff seconded the motion. Mayor Carter called for comments, there being none, the motion passed unanimously. 5-0.
- 11. Consider a request to authorize and approve payment of Tackett Builders Invoice No. 3, as submitted, for \$25,837.19 for the Hambley Athletic Complex Fieldhouse Roof Repair Project and grant the Mayor the authority to sign and execute any and all necessary documents. Commissioner Hartsock made the motion to approve. Commissioner May-Downey seconded the motion. Mayor Carter called for comments, there being none, the motion passed unanimously. 5-0.

Russell Davis was absent so City Manager read the following items into record.

 Consider a second reading of Ordinance 0-2018-20, as submitted, amending Chapter 72 to allow the City Manager to designate parking zones and grant the Mayor the authority to sign and execute said ordinance on behalf of the City of Pikeville. Commissioner Hartsock made the motion to approve. Commissioner Shurtleff seconded the motion. Mayor Carter called for comments, there being none, Mayor called roll call.

2. Consider a second reading of Ordinance 0-2018-21, as submitted, amending Chapter 72.003 to allow the regulation and restriction of parking within City Buildings, Property, Parks, Recreational Facilities, and other City Facilities and grant the Mayor the authority to sign and execute said ordinance on behalf of the City of Pikeville. Commissioner McNamee made the motion to approve. Commissioner Hartsock seconded the motion. Mayor Carter called for comments. Mr. Elswick explains that these two ordinances close a hole in our current ordinances pertaining to parking around the City. Currently there are people parking at the bottom of Bob Amos and carpooling and we

hope this will fix the matter. Mayor called for additional comments, there being none, Mayor called roll call.

3. Consider a first reading of Ordinance 0-2018-22, as submitted, amending Chapter 53 to increase the wholesale water rate for Southern Water and Sewer District. Second reading and passage of this ordinance will take place at next scheduled commission meeting.

CITY MANAGER

City Manager Philip Elswick presented the commission with the following items for approval:

- Consider a request to waive the permitting requirements for food trucks at the 2D District Event to be held on September 29, 2018. Commissioner Hartsock made the motion to approve. Commissioner McNamee seconded the motion. Mayor Carter called for comments, there being none, motion passed unanimously. 5-0.
- 2. Consider a request to authorize and approve payment of an Appalachian Newspapers, Inc. invoice, as submitted, for \$904.00 for the Pikeville Farmers Market. All invoices will be paid with grant funds. Commissioner McNamee made the motion to approve. Commissioner May-Downey seconded the motion. Mayor Carter called for comments. City Manager says that the grant is for a specific amount of time and does not think it is an annual renewal. Mayor called for additional comments, there being none, the motion passed unanimously. 5-0.
- 3. Consider a request to adopt a resolution authorizing and approving the providing of irrevocable instructions to the trustee of the City of Pikeville Hospital Improvement refunding revenue bonds (Pikeville Medical Center, Inc. Expansion Project), Series 2011, Serials, Terms 26, and Term 31 (the "Bonds") with respect to the defeasance and redemption of a portion of the bonds upon the request of Pikeville Medical Center, Inc. Commissioner McNamee made the motion to approve. Commissioner Shurtleff seconded the motion. Mayor Carter called for comments. Commissioner May-Downey says that the original letter identified the particular bonds they wanted to do this with. Do we need to include that in this. City Manager says he will get an

- answer for her on that. Mayor adds that they are basically paying off these bonds early. Mayor then called for additional comments, there being none, the motion passed unanimously. 5-0.
- 4. Consider a request to authorize and approve amended rental rates, as submitted, for community centers, shelters, and the Pikeville Pavilion. Commissioner Hartsock made the motion to approve. Commissioner McNamee seconded the motion. Mayor Carter called for comments, there being none, the motion passed unanimously. 5-0.
- 5. Consider a request to authorize and approve nunc pro tunc cancelation of an agreement with Payment Service Network, Inc. and grant Rebecca Hamilton, Tax Administrator, the authority to sign and execute any and all necessary documents. Commissioner McNamee made the motion to approve. Commissioner May-Downey seconded the motion. Mayor Carter called for comments. Mr. Elswick explains that we are canceling this service to accept utility services online with Logics because we no longer need the PSN program. Mayor called for additional comments, there being none, the motion passed unanimously. 5-0.
- 6. Consider a request to reject all Statements of Qualifications received on January 19, 2017 in response to an RFP issued for a Public/Private Partnership for FTTP Network. Commissioner McNamee made the motion to approve. Commissioner Hartsock seconded the motion. Mayor Carter called for comments. City Manager says that we requested that the firms respond in three ways and we are now looking at a new model so we need to do this in order to proceed. Mayor called for additional comments, there being none, the motion passed unanimously. 5-0.
- 7. Consider a request to authorize and approve issuance of a Request for Proposals for the construction, operations, and maintenance of the City of Pikeville Fiber Optic Network. Commissioner McNamee made the motion to approve. Commissioner May-Downey seconded the motion. Mayor Carter called for comments. Mr. Elswick adds that we are seeking firms that will construct, operate, and maintain and offer payback terms while meeting certain standards for price and speed. Mayor called for additional comments, there being none, the motion passed unanimously. 5-0.
- 8. Consider a request to authorize and approve the advertisement for bid for the 2018-2019 Curb and Sidewalk Repair & Reconstruction Project. Commissioner Hartsock made the motion to approve. Commissioner May-Downey seconded the motion. Mayor Carter called for comments, there being none, the motion passed unanimously. 5-0.
- 9. Pursuant to KRS 61.810, consider request for closed session for discussion of economic development, legal and personnel issues. Commissioner McNamee made the motion. Commissioner May-Downey seconded the motion. Mayor Carter called for discussion, there being none, the motion passed unanimously. 5-0.
- 10. Commissioner McNamee made the motion to reconvene. Commissioner May-Downey seconded the motion. Mayor Carter called for discussion, there

- being none, the motion passed unanimously. 5-0. Mayor called the session back into order.
- 11. Consider a request to authorize the HR administrator to advertise for the position of Traffic Control Officer. Commissioner McNamee made the motion to approve. Commissioner May-Downey seconded the motion. Mayor Carter called for comments, there being none, the motion passed unanimously. 5-0.
- 12. Consider a request to appoint Brad Slone to the Hatfield & McCoy Pikeville/Pike County Museum Board for the unexpired term of Sean Cochran, who resigned, which will expire on April 1, 2021. Commissioner McNamee made the motion to approve. Commissioner May-Downey seconded the motion. Mayor Carter called for comments, there being none, the motion passed unanimously. 5-0.
- 13. There being no further business to come before the Commission, Commissioner McNamee has made the motion to adjourn the meeting. Commissioner May-Downey seconded the motion. Mayor Carter called for discussion, there being none, the meeting was adjourned. 5-0.
