# CITY OF PIKEVILLE BOARD OF COMMISSIONERS REGULAR MEETING MINUTES June 28, 2021 AT 6:00 P.M.

The Board of Commissioners for the City of Pikeville met in a regular called session on Monday, June 28, 2021. The meeting was held in the City Hall Meeting Room located at 243 Main Street, Pikeville, Kentucky 41501.

#### **MINUTES**

The minutes for the previous regular meeting held on June 14, 2021 were in each Commissioner's agenda package. There being no additions or corrections, Commissioner Shurtleff made the motion to approve the minutes as prepared. Commissioner Hartsock seconded the motion. Mayor Jimmy Carter called for discussion, there being none, the motion carried unanimously. 3-0.

## BUSINESS FROM THE FLOOR

Joe Dan Vanhoose presented a check in the amount of \$1,270 to the City of Pikeville to support the city's Trailtown initiative. The money was raised through a bicycle event in memory of Dr. Alex Poulos. Mr. Vanhoose was very complimentary of the assistance provided by the City of Pikeville and specifically Andy Linton, Director of Events.

## PAYMENT OF CITY BILLS

The City Manager Philip Elswick requested the approval to pay city bills in the amount of \$1,391,055.56. Commissioner Shurtleff made the motion to approve. Commissioner Hartsock seconded the motion. Mayor Carter called for discussion, there being none, the motion passed unanimously. 3-0.
