CITY OF PIKEVILLE BOARD OF COMMISSIONERS REGULAR MEETING MINUTES October 11, 2021 AT 6:00 P.M.

The Board of Commissioners for the City of Pikeville met in a regular called session on Monday, October 11, 2021. The meeting was held in the City Hall Meeting Room located at 243 Main Street, Pikeville, Kentucky 41501.

There being a quorum present, Mayor James A. Carter called the meeting to order at 6:00 p.m. Commission Members present at roll call were as follows:

MINUTES

The minutes for the previous regular meeting held on September 27, 2021 were in each Commissioner's agenda package. There being no additions or corrections, Commissioner McNamee made the motion to approve the minutes as prepared. Commissioner Powers seconded the motion. Mayor Jimmy Carter called for discussion, there being none, the motion carried unanimously. 5-0.

PAYMENT OF CITY BILLS

The City Manager Philip Elswick requested the approval to pay city bills in the amount of \$689,990.88. Commissioner McNamee made the motion to approve. Commissioner Hartsock seconded the motion. Mayor Carter called for discussion, there being none, the motion passed unanimously. 5-0.

CITY ENGINEER

Brad Slone was present and submitted several requests to the Commission for approval.

1. Consider a request to authorize and approve Edwards Fence Group dba First Guard Fence Change Order No. 1, as submitted, for a reduction of \$2,564.29 for the Bob Amos Tennis Court Fence Replacement project and grant the Mayor the authority to sign and execute any and all necessary

- documents. Commissioner McNamee made the motion to approve. Commissioner Hartsock seconded the motion. Mayor Carter called for comments, there being none, the motion passed unanimously. 5-0.
- 2. Consider a request to authorize and approve Edward Fence Group dba First Guard Fence Invoice No. 2, as submitted, for \$31,063.59 for the Bob Amos Tennis Court Fence Replacement project and grant the Mayor the authority to sign and execute any and all necessary documents. Commissioner Powers made the motion to approve. Commissioner McNamee seconded the motion. Mayor Carter called for comments, there being none, the motion passed unanimously. 5-0.

Consider a request to authorize and approve an Easement Agreement, as submitted, with Inter Mountain Cable, Inc. for a Downtown Fiber Hub Building in support of the Pikeville Broadband project and grant the Mayor the authority to sign and execute any and all necessary documents. Emergency order to approve and grant the Mayor the authority to sign and execute said ordinance on behalf of the City of Pikeville. Commissioner Hartsock made the motion to approve. Commissioner McNamee seconded the motion. Mayor Carter called for comments, there being none, Mayor called for Roll Call.

City Manager Philip Elswick presented the Commission with the following items for approval:

The City Manager explained that the grant would fund development of product development throughout the region include a 200,000 SF building at Kentucky Enterprise Industrial Park. The motion passed unanimously. 5-0

Consider a request to authorize and approve serving as a co-applicant with the University of Pikeville for an EDA Economic Adjustment Assistance grant application for establishment of an Ag-Tech Innovation Center of Excellence at Kentucky Enterprise Industrial Park, authorize and approve a letter of support for said project, as submitted, and grant the Mayor the authority to sign and execute any and all necessary documents. - made the motion to approve. Commissioner Shurtleff seconded the motion. Mayor Carter called for comments, there being none, the motion passed unanimously. 5-0.
- 3. Consider a request to amend the City of Pikeville Pay Chart Dated October 11, 2021, as submitted, authorize and approve a Patrolman/Public Information Office/Parking Enforcement/Environmental Enforcement job description, as submitted, and appoint Tony Conn to the position at the 5-year rate of pay. Commissioner Powers made the motion to approve. Commissioner Hartsock seconded the motion. Commissioner Shurtleff abstained. Mayor Carter called for comments, there being none, the motion passed unanimously. 5-0
- 4. Consider a request to authorize and approve a curb cut at 109 Myra Barnes Avenue upon submittal of an acceptable design to the City Manager and grant the Mayor the authority to sign and execute any and all necessary documents. Commissioner McNamee made the motion. Commissioner Hartsock seconded the motion. Mayor Carter called for comments. - 6. Consider a request to reconvene the meeting out of closed session into regular session. Commissioner McNamee made the motion to approve. Commissioner Powers seconded the motion. Mayor Carter called to reconvene. 5-0

Consider a request to authorize and approve awarding a negotiated proposal to Boggs Municipal Services, Inc. for the purchase of a water treatment plant backwash pump, as submitted, for \$77,800.00 and grant the Mayor the authority to sign and execute any and all necessary documents. Commissioner McNamee made the motion to approve. Commissioner Hartsock seconded the motion. Mayor Carter called for comments there being none, motion passed unanimously. 5-0
