CITY OF PIKEVILLE BOARD OF COMMISSIONERS REGULAR MEETING MINUTES January 25, 2021 AT 6:00 P.M.

The Board of Commissioners for the City of Pikeville met in a regular called session on Monday, December 28, 2020. The meeting was held via live broadcast on http://livestream.com/pikeville/events/9494852 due to Governor Beshear's declaration of a State of Emergency to prevent the spread of the Novel Coronavirus (COVID-19)

The minutes for the previous regular meeting held on January 11, 2020 were in each Commissioner's agenda package. There being no additions or corrections, Commissioner McNamee made the motion to approve the minutes as prepared. Commissioner Hartsock seconded the motion. Mayor Jimmy Carter called for discussion, there being none, the motion carried unanimously. 5-0.

BUSINESS FROM THE FLOOR
