CITY OF PIKEVILLE BOARD OF COMMISSIONERS REGULAR MEETING MINUTES December 13, 2021 AT 6:00 P.M.

The Board of Commissioners for the City of Pikeville met in a regular called session on Monday, December 13, 2021. The meeting was held in the City Hall Meeting Room located at 243 Main Street, Pikeville, Kentucky 41501.

MINUTES

The minutes for the previous regular meeting held on November 22, 2021 were in each Commissioner's agenda package. There being no additions or corrections, Commissioner McNamee made the motion to approve the minutes as prepared. Commissioner Powers seconded the motion. Mayor Jimmy Carter called for discussion, there being none, the motion carried unanimously. 5-0.

BUSINESS FROM THE FLOOR

Elizabeth Thompson was recognized for her work authoring "Hammy Visits the Police Station" children's book. Elizabeth stated she wanted to help give back to the community by collecting donations for the "Shop with a First Responder" event. As an English major, she decided to write a children's book that can be sold for a small fee of \$5.00 with proceeds going towards Shop with a First Responder. After writing the book, she spoke with Jeff Vanderbeck from the Appalachian News Express about publishing it. Jeff was able to get Chris Epling to illustrate the book, Russ Cassady of ANE edited the book, PMC is the primary sponsor, and ANE printed the book.
