

# CITY OF PIKEVILLE BOARD OF COMMISSIONERS REGULAR MEETING MINUTES JULY 10, 2023 AT 6:00 P.M.

The Board of Commissioners for the City of Pikeville met in a regular called session on Monday, July 10, 2023. The meeting was held in the City Hall Meeting Room located at 243 Main Street, Pikeville, Kentucky 41501.

There being a quorum present, Mayor James A. Carter called the meeting to order at 6:00 p.m. Members present at roll call were as follows:

### **MINUTES**

The minutes for the previous special meeting held on July 3, 2023 were in each Commissioner's agenda package. There being no additions or corrections, Commissioner McNamee made the motion to approve the minutes as prepared. Commissioner Hartsock seconded the motion. Mayor Carter called for discussion, there being none, the motion carried unanimously. 5-0

#### BUSINESS FROM THE FLOOR

Members from the Pikeville VFW were present and explained to the commission that due to the expansion of added members and being present within the City; the current building they occupied on 119 Second Street wasn't large enough for the space they needed. Members explained the community outreach and programs they were helping with, which required more space, at this time they were inquiring about using the building at Bob Amos Park at the end of the track. Mayor Carter and Commission each



commented, that at this time due do the facility being in use for the City they cannot commit without knowing what or how much space the City needed keep.

#### PAYMENT OF CITY BILLS

Interim City Manager Brad Slone requested the approval to pay city bills in the amount of \$1,073,908.76. Commissioner Powers made the motion to approve. Commissioner McNamee seconded the motion. Mayor Carter called for discussion, there being none, the motion passed unanimously. 5-0

Brad Slone read and submitted several requests to the Commission for approval.
