

# CITY OF PIKEVILLE BOARD OF COMMISSIONERS REGULAR MEETING MINUTES JULY 24, 2023 AT 6:00 P.M.

The Board of Commissioners for the City of Pikeville met in a regular called session on Monday, July 24, 2023. The meeting was held in the City Hall Meeting Room located at 243 Main Street, Pikeville, Kentucky 41501.

There being a quorum present, Mayor James A. Carter called the meeting to order at 6:00 p.m. Members present at roll call were as follows:

#### **MINUTES**

The minutes for the previous regular meeting held on July 10, 2023 were in each Commissioner's agenda package. There being no additions or corrections, Commissioner McNamee made the motion to approve the minutes as prepared. Commissioner Powers seconded the motion. Mayor Carter called for discussion, there being none, the motion carried unanimously. 5-0

## BUSINESS FROM THE FLOOR

VernaLisa Stambaugh, USA Pickleball Ambassador addressed the commission on the need for additional courts, along with lighting and open play schedules at the current Pickleball Courts. Ms. Stambaugh stated there was a need for additional courts as there are more players than courts. Mayor Carter commented we do have cameras in that area that we can review the usage to see how often the courts are being used and if there is the need for additional courts, we will definitely look for an area to put those we want more people to be able to use. As for the lighting we have poles already set there, which



shouldn't be an issue to add the lighting. Mayor Carter stated, just give us some time to review, and gather the information needed.

Justin Prater, CMO Ken's Towing, presented himself to the Commission, inviting everyone to the ribbon cutting on August 1, 2023 at noon; 519 N Mayo Trail.

## PAYMENT OF CITY BILLS

Interim City Manager Brad Slone requested the approval to pay city bills in the amount of \$1,600,841.81. Commissioner McNamee made the motion to approve. Commissioner Hartsock seconded the motion. Mayor Carter called for discussion, there being none, the motion passed unanimously. 5-0

#### CITY ENGINEER

Brad Slone read and submitted several requests to the Commission for approval.

- Consider a request to authorize and approve payment of H20 Construction Co., Inc. Invoice No. WO #489-729, as submitted for \$52,845.00 for the Melvina Drive Storm Drainage Repair project and grant the Mayor the authority to sign and execute any and all necessary documents. Commissioner Hartsock made the motion to approve. Commissioner McNamee seconded the motion. Mayor Carter called for comments, there being none, the motion passed unanimously. 5-0
- 2. Consider a request to authorize and approve Rising Sun Developing, Inc. Change Order No. 2 for \$26,529.32 and seven days, as submitted, for the Pikeville Fire Station No. 2 project and grant the Mayor the authority to sign and execute any and all necessary documents. Commissioner Powers made the motion to approve. Commissioner Shurtleff seconded the motion. Mayor Carter called for comments, there being none, the motion passed unanimously. 5-0
- 3. Consider a request to authorize and approve Commonwealth Building & Construction Co., Inc. Change Order No. 1 for \$70,800.00, as submitted, for the City Hall Exterior Refurbishment and Window Repairs project and grant the Mayor the authority to sign and execute any and all necessary documents.   provided the lower quote, for \$9,175.00 for the Division Street Parking project and
  grant the Mayor the authority to sign and execute any and all necessary documents.

Commissioner Hartsock made the motion to approve. Commissioner McNamee seconded the motion. Mayor Carter called for comments, there being none, the motion passed unanimously. 5-0
- 7. Consider a request to award a bid to Fannin Construction, LLC, the low bidder, as submitted, for \$30,200.00 for the demolition of 167, 169, and 171 Ferguson Lane and grant the Mayor the authority to sign and execute any and all necessary documents. Commissioner Powers made the motion to approve. Commissioner Hartsock seconded the motion. Mayor Carter called for comments, there being none, the motion passed unanimously. 5-0

Consider a request to support the Pikeville Affordable Housing Corporation's application for funding from the Kentucky Housing Corporation, as submitted, and grant the Mayor the authority to sign and execute any and all necessary documents. Commissioner McNamee made the motion to approve. Commissioner Powers seconded the motion. Mayor Carter called for comments, there being none, the motion passed unanimously. 5-0
- 4. Consider a request to approve an agreement with Paul Corbin regarding maintenance of waterline beyond his meter at Walters Road to two City of Pikeville meters and grant the Mayor the authority to sign and execute any and all necessary documents upon completion of negotiations by the Interim City Manager and the City Attorney. Commissioner Hartsock made the motion to approve. Commissioner McNamee seconded the motion. Mayor Carter called for comment, there being none, the motion passed unanimously. 5-0
- Consider a request to designate Brad Slone as authorized signer for Motor Vehicle
  Leases with Enterprise Fleet Management and grant the Mayor the authority to
  sign and execute any and all necessary documents. Commissioner Powers made the

Consider a request to authorize and approve a Usage Agreement with Community Trust Bank, Inc., as submitted, for use of the Hambley Athletic Complex for the 2023 Pike County Bowl and grant the Mayor the authority to sign and execute any and all necessary documents upon completion of negotiations by the Interim City Manager and City Attorney. Commissioner Hartsock made the motion to approve. Commissioner Powers seconded the motion. Mayor Carter called for comments, Commissioner Shurtleff abstained, Mayor called for additional comments, there being none, the motion passed unanimously. 4-0 1-abstention.
- 12. Pursuant to KRS 61.810, consider a request for closed session for the purpose of discussion of economic development, legal, and personnel issues. Commissioner McNamee made the motion to approve. Commissioner Hartsock seconded the motion. Mayor Carter called for comments, there being none, the motion passed unanimously. 5-0
- 13. Consider a request to reconvene the meeting out of closed session into regular session. Commissioner McNamee made the motion to approve. Commissioner Powers seconded the motion. Mayor Carter called for comments, there being none, the motion passed unanimously. 5-0
- 14. Consider a request to authorize the Director of Human Resources to post an advertisement for a position for an Environmental Codes/Assistant Building



Codes Officer. Commissioner McNamee made the motion to approve. Commissioner Powers seconded the motion. Mayor Carter called for comments, there being none, the motion passed unanimously. 5-0
