

## CITY OF PIKEVILLE BOARD OF COMMISSIONERS REGULAR MEETING MINUTES JUNE 12, 2023 AT 6:00 P.M.

The Board of Commissioners for the City of Pikeville met in a regular called session on Monday, June 12, 2023. The meeting was held in the City Hall Meeting Room located at 243 Main Street, Pikeville, Kentucky 41501.

#### **MINUTES**

The minutes for the previous special meeting held on May 22, 2023 were in each Commissioner's agenda package. There being no additions or corrections, Commissioner Powers made the motion to approve the minutes as prepared. Commissioner McNamee seconded the motion. Mayor Carter called for discussion, there being none, the motion carried unanimously. 4-0

#### BUSINESS FROM THE FLOOR

Business recognitions were presented to Weddington Floral and Reynold's Produce by Lisa Sizemore, Business Retention and Expansion Manager.

Tammy Riley with the Pike County Health Department presented the commission with a health update. The update included grants awarded to the department give the community and students a variety of different health sessions.



#### PAYMENT OF CITY BILLS
