The Board of Commissioners for the City of Pikeville met in a special called session on Wednesday, September 1, 2023. The meeting was held in the City Hall Meeting Room located at 243 Main Street, Pikeville, Kentucky 41501.

- (1) There being a quorum present, Mayor James A. Carter called the meeting to order at 6:00 p.m. Members present at roll call were as follows:

- (2) The minutes for the previous special meeting held on August 30, 2023 were in each Commissioner's agenda package. There being no additions or corrections, Commissioner McNamee made the motion to approve the minutes as prepared. Commissioner Hartsock seconded the motion. Mayor Carter called for discussion, there being none, the motion carried unanimously. 4-0
- (3) Consider a request to hire for the position of City Manager at the rate of pay for said position contingent upon completion of all pre-employment screenings. Mayor Carter spoke before the naming of City Manager. Mayor Carter stated the search of City Manager was nationwide, with numerous invites and advertisements of the position. There were 28 applications, and narrowed to 4 applicants, 2 from Kentucky, 1 from Virginia and 1 from Utah. The 4 took an assessment test and were interviewed by the Commission and myself. Mr. Reggie Hickman knocked it out of the Ballpark. Kentucky League of Cities also aided in the process, and were highly impressed on how well Mr. Hickman scored. Mayor Carter also commended Interim City Manager, Brad Slone, for stepping in to fulfill the duties of the position while the search was underway. Mr. Reggie Hickman, commented, "I am excited to serve the Community of Pikeville and look forward to working with this strong team to expand and develop services for Pikeville." Commissioner McNamee made the motion to approve. Commissioner Hartsock seconded the motion. Mayor Carter called for comments, there being none, the motion passed unanimously. 4-0
- (4) There being no further business to come before the Commission, Commissioner McNamee made the motion to adjourn the meeting. Commissioner Hartsock
